

TAKE NOTICE THAT, under Section 492(1) and Section 493(1)(a)(2)(a) of the *Local Government Act*, the Applicant has applied for a Temporary Use Permit to allow for an RV to be used as a temporary residence while building their permanent residence, approximately until October 31, 2024, as indicated in a red box on 'IMAGE 1' above. The property is legally described as Lot 7 District Lot 4274 Kootenay District Plan NEP90881, 200 Cotswold Road.

200 Cotswold Road is Zoned RU1- Rural, which allows for residential use. The applicants would like to use their recreation vehicle as a temporary residence until they can get their occupancy permit. Zoning Bylaw 729, 2023, states that a Recreation Vehicle can be used as a temporary residence for 21 day between April 1 and October 31 and may be permitted more than 21 days (between April 1 and October 31) subject to the issuance of a Temporary Use Permit.

Reason:

A Temporary Use Permit will allow the applicants to live in their recreation vehicle until October 31, 2024, while building their permanent residence.
